### 1. The structure and the objectives of the Interim Conference

The Interim conference of the WildFood project has been held on 26<sup>th</sup> 27<sup>th</sup> May, in Castelfranco Veneto (Italy) at Villa Bolasco. The event, organized in the context of WP 5 of the project, has been coordinated by UNIPD team, with the collaboration of all WP leaders. Initially, the conference was initially scheduled for March 2022, but due to COVID-19 restrictions it was postponed to the end of May 2022. The conference aimed to provide a state of the art of the WildFood project, present the main findings reached, as well as to host the policy forum on certification and labelling of Wild Food Products, included in the task 3.2 of the proposal.

As described below, the conference was divided into 2 days, and in each of these days various moments of discussion and interaction were organized to encourage the participation of all project partners and other interested stakeholders. It should be emphasized, in fact, that a large part of the event was broadcast online and all partners, even if not physically present, were able to interact with the rest of the audience. An example of moment of interactions between participants (on-line) and participants (physically present) is reported in Annex I (picture 2).

### 2. The conference participants

As described in Table 1, more than 20 participants attended both days of the event, although some representatives of the project partners attended the event, in online mode. It should also be noted that some speakers of the Policy Forum, such as Sven Mutke, were invited as guests of the first day (26<sup>th</sup> May), as possible providers of inputs and suggestions for a correct project implementation. As already mentioned, some parts of the event were broadcast online and therefore, in addition to the project partners, other interested actors (about 10) were able to attend (not as participants, but as only as auditors) to the event.

The third part of the first day was totally dedicated to the analysis of the next project activities, clarifying the timeline, identifying possible barriers (and possible solutions) that may emerge during the implementation of these activities. Barriers and possible solutions have been identified by participants during some specific participatory activities, coordinated by UNIPD staff. In detail:

- UNIPD team has introduced the main contents of the training programs, that will be organized in the context of the task 5.2. **Main discussion topics**: language and role of each partner in the training courses organization;
- SFI team has proposed the methodology that will be utilized for the creation of innovative Business Model for the WFP sector, as requested by the task 4.4. **Main discussion topics:** the meaning of innovation in a business model for wild food products;
- PRODECA has introduced the main features of the virtual fair, that will be launched in the context of the task 4.1. **Main discussion topics:** the involvement of private companies in the virtual fair.

The policy forum (from 9.00 to 11.20) has been devoted to an analysis of the role of labeling, certifications and private brands of wild food products, defining the actions necessary to ensure greater competitiveness, safety and sustainable value chains of wild foods. The policy forum has been divided in two different sessions:

- **The plenary session**, based on the presentations of wildfood experts, aimed to contribute the beginning of a debate to outline the priorities for the adoption of smart labels and / or wild food certifications.
- The world Cafè for collecting inputs from all the participants regarding: (i) Opportunities & Barriers behind certifying, labelling and branding wild food, (ii) Particularities of wild food to be considered before defining a new certification scheme (iii) Prioritized actions and policy recommendations.

Main outputs of the policy forum, emerged during both plenary session and world cafè will be summarized in a document, called "*Report on innovative certification and labelling in WFPs sector: Pilot experiences*", that represent the deliverable 3.4 of WildFood project.

The last part of the event (Research in action) has been dedicated to a presentation of specific findings emerged during scientific research on wildfood value chains, carrying on researchers, included in WildFood project. Below (Table 6) it is reported the name of speakers and the reference of their presentations
